1. Upon the presentation of the Agenda, Comm. Kroll motioned to approve said agenda with Comm. Fuller seconding the motion.
2. Upon the presentation of the February meeting Minutes, Comm. Kroll motioned to approve said February meeting minutes with Comm. Fuller seconding the motion.
3. A welcome call to the audience is made by Comm. Colson.
4. Liaison Report:
 - a. Comm. Colson provided the commission with the following updates: From Holland HRC: Fairing Housing Learning Event on 4/11/2024 and Crisis Response Training Video available on HRC website. Holland DEIA Micro Aggression Training offered early April as well as a Know your Community Series.
 - b. Barbara Lee VanHorssen stated the Momentum Center will host the movie “The Great Disconnect” on 4/12/2024 and “Screenagers Under the Influence” on 5/10/2024 which included dinner. An “Emerging Drug Trends” Town Hall will be held on 5/14/2024. CMH board members are not advocating for mental health mileage. Losing mental health mileage support means losing potential valuable funding for the Momentum Center. Community conversation, support, and advocacy is needed.

 - e. Discussed community resources for victims of sexual crimes such as the Holland Child Advocacy Center and the Child Anti exploitation Partnership Program in Ottawa County.
