**Call to order:** Vice-Chair Robyn Vandenberg at 5:00pm

**Roll call of members present:** Commission Members Liza Dora, Chad Fisk, Linda Rosema, and Wendy Knoth.

**1) General Business Call to Viewing Audience – none**

**2) Approval of the May 19 and June 16, 2022, Regular Meeting Minutes –**Motion by Dora, second by Vandenberg. Approved unanimously.

**3) Planning Commission Site Plan Reviews**

[Refer to City Ordinance Ch 19-16(3) and Mainstreet Guidelines]

A "Site Plan Review" for 300 Washington, a residential condominium addition to the Capstone building was to be held on Wednesday, July 20 but was reschedule for Wednesday, July 27 (in preparation for the Planning Commission). Much discussion was held regarding this project and the historical significance of the original building that still exists prior to additions and last remodel of exterior. Member Dora reminded the commission that the original building was built in 1909 and was the Peoples Savings Bank of Grand Haven. The museum and library representatives reminded the commission that the bank is where the famous bank robbery of 1933 occurred. Member Fisk pointed out that the current architecture of the former bank building is historically significant due to the Art Deco style of the late 60's of its time; much of this architecture is being lost currently. The commission is of the consensus that it would be very difficult to bring the building back to its original architecture due to the fact that the current building encompasses 2 buildings and it is unknown what shape the original structure's exterior would be in when attaching the current façade.

Fisk motioned to recommend revising the color of the fiber cement board to a more neutral color that enhances the current façade and recommended investigating alternative materials that reflect the current façade. Second by Rosema. Approved unanimously.

**4) Tri-Cities Museum Advisory Member Update**

She also reminded everyone that Collective Access is fully up and running and is a great way to find out all types of information about Grand Haven, from commercial buildings to private residences. **5) Loutit District Library Events Update**

Jeannette Weiden, Loutit District Library Representative, reported that the summer Grand Adventures reading program is wrapping up. It was a great way to get people into the library this summer. At 6pm on this evening they were offering a lecture: Vintage Views of Michigan Tourist Attractions. For this fall they are collaborating with the Tri-Cities Museum and area schools for the upcoming Civil War and Noah Ferry (resident killed at Gettysburg) commemoration. There will be Civil War Gettysburg cemetery tours on November 1. The 5<sup>th</sup> Michigan Calvary Reenactors will also be performing at GHHS. Eric Wittenburg, Civil War Historian, will have a lecture at the library during this commemoration as well.

Dora reported that the HCDC, along with their families, have been invited by Andy Cawthon, Fountain Committee member, to tour the Musical Fountain facility after Coast Guard. Members were excited to have this opportunity.
