a. Diversity & Inclusion AwarenessColson
Pride Flags project
Colson reported that he had heard from several businesses interested in participating in the Pride Flag project. Colson stated he had dropped off flyers and was working to follow up with businesses individually. He noted that a handful of businesses expressed that they would only like to have the flags up for one day. Colson also reported that Loutit Library had confirmed they will conduct a Story Walk regarding DEI, LGBTQ+ representation during the first week of June.
