7. **Liaison Reports Chamber**
Barbara Lee VanHorssen, *Momentum Center*, reported that the center was celebrating its seventh year as a nonprofit and will be hosting an anniversary event. VanHorssen updated the commission on the Town Halls, Just Goods Café, Cultural Immersion experiences and the Anti-racism taskforce.

VanHorssen expressed concern about the current political environment and explained that the center will be hosting a voter turnout and vaccination event in October.

VanHorssen updated the group on the Holland location; explaining the focus of the location is mental illness and disability, and that they were more-so exploring the community facing piece. She added they will be considering an ice cream or food truck onsite.

Mary Jane Evink, *GHAPS*, reported the work being completed by the diversity committee at the school; explaining that in the current climate the strengths and weaknesses of the district became obvious. Evink added that the district was undergoing implicit bias training, creating a DEI focused newsletter, and being intentional about diversifying the library collection.

Pride Flags project

Colson reported that around ten businesses would be participating and the flags would be delivered the following Saturday. Colson explained that the Tribune agreed to report on the effort and that the Library would be conducting a Story Walk June 6-12 in Central Park with a Pride theme.

“Humans of GH” project

Latsch explained that City Council elected to not complete a calendar in 2023 due to general budget constraints.

Lyons expressed that a digital option would be a great alternative; or that the Commission could consider fundraising to complete their own calendar.

Werksma added that the Commission could have a nonprofit sponsor each month and use their platform to promote the cause.

Lyons concluded that she would convene the communications committee to plan and further discuss.
