Director's Report

- Match on Main Grant Round Two
Second round is underway. We can apply for up to two businesses. Last round was 70 applications with 20 awards. Jeremy will work with applicants, narrow the list and assist the two most likely candidates with an application.
- Outdoor Dining Update
Will be presented at the February 21 City Council meeting for direction from Council. Need to work out details with Social District, Special Events, and individual applicant's needs.
- Beyond The Pier Update



Two informational sessions were held last week.

- **Farmer's Market Board Position**
There is a Farmer's Market Advisory Board and currently needs an appointee from the MSDDA. Next meeting is April 14, 2022. They meet about four times per year.
- **BLP/City Council Meeting**
Snowmelt is one of the items under discussion when Council and BLP meet. The \$1 million boiler investment remains unresolved. The MSDDA's position remains that the liability cannot be passed on to property owners along Washington.
- **Marijuana Survey**
Jeremy reported that the survey is being worked on. He gave an update on the mechanics of the process.

Board Comments

- **Incubator Shops**
The Board discussed the concept and future ideas to promote new small businesses get ready for doing business in our downtown.
- **Cycle Back to Centertown**
Joyce announced that on May 7 there will be a new event. Two food trucks, vintage bicycles, presentations, help kids get bikes ready for Memorial Day parade, GH Public Safety will provide bike safety advice and many other fresh and fun ideas!
- **Bike Rentals**
Sharon expressed concern about the bike rental operation needs to be proactive in notifying customers that bike riding is not permitted on sidewalks downtown – no wheel zone Memorial Day through Labor Day on downtown sidewalks.
- **Parking**
Dave reminded the board of the perceived parking problem downtown and our mission to work on improvements.
