Beyond the Pier – Next Steps

Jeremy Swiftney and Cara Galbavi provided update to the Board. The process continues to be full of input from the community and steering committee. An issue was discovered with the information provided in the plan just prior to the last City Council meeting, specifically regarding the parking lots being the highest reported desired area for development, when in reality the Chinook Pier area itself was the ranked the highest. The numbers were flipped in reporting, so Williams and Works is working on a new revised plan to reflect the accurate results which will be given to the steering committee next Friday for review. Once the steering committee meets, Jeremy and Cara will then bring that new report back to the Board, so we can review, and do what is best for our stakeholders and continue the vibrancy for our district.

Bob Monetza reported his attempt to explain the rationale of the DDA to the Planning Commission and urges all committees, the DDA included, to take as much time as needed to review the plans as they come before us.

Jeremy Swiftney gave update, including displaying the eight available banner options. Timeline and locations are being worked on with DPW for setting up before Memorial Day.
