Coast Guard Festival – Request of Social District Closure

Jeremy reported that the Festival Board has asked that the Social District be rendered closed during the Coast Guard Festival while the Carnival is operating, Monday August 1 – Saturday August 6. Jeremy spoke to operators at Anna's House, Odd Side, Kirby, Long Road and Armory. All opposed the Coast Guard Festival request to close the Social District during these days except Anna's House.

Sharon informed the members that the Board requested this to promote a family friendly theme during the event.

Members shared their thoughts and ideas about whether the MSDDA should or should not recommend a closure during Coast Guard Festival. Crowd size, refuse generation, sign plan, retailer's ability to sell beverages and other impacts should be considered.

Snowmelt Cost Estimates from Winter of 2021/2022

Executive Committee does not recommend approval of including interest charge from BLP to stakeholders. The total cost for 2021-2022 was \$126,076. Interest on snowmelt investment in 2021 – 2022 was \$21,921. The BLP remains unpaid for the cost of their decision to convert the energy supply from coal to natural gas.

Motion by Todd Anthes to recommend the interest fees charged by BLP in 2021-2022 not be included in the cost allocation, second by Bob Warren.

Paid Parking Discussion/Direction

Cara advised that her recollection of what occurred in 2019 was a motion to continue the discussion, not to support the plan as presented at that time. The Recruitment and Retention Committee would like clarification of the Board's position on paid parking downtown today. Pat gave a brief background of how the issue has evolved over the years. Todd and Cathy commented on the proposed uses of funds – are we talking about building resources for future parking capacity or to relieve General Fund?

Members discussed a survey that was conducted by Doug Vance, Copper Post owner, about retailer preferences about paid parking. He asked a question of whoever was in the store "do you support paid parking downtown?" Responses were overwhelmingly opposed to paid parking, but the method and approach are not a valid nor reliable measurement tool.

The Board was comfortable with asking the Recruitment and Retention Committee to continue discussing possible impacts and offering advice to the Board.

Director's Report

Recreational Marijuana Survey

Jeremy is conducting a survey on attitudes in the district about recreational marijuana. We are not asking opinions outside of the district – only business owners, residents and building owners in the district will be responding to the survey.

Pat reported on a plan to apply for funding for the preservation of the 1870 Grand Trunk Depot. Jeremy will be out next week at a conference. He will be back by Thursday, May 19.
