5. Treasurer's Report

i. Review and approve the amended Grand Haven Main Street DDA budget for fiscal year 2025/26. The amended budget reflects updated revenue projections and expense adjustments necessary to align with organizational priorities and current financial conditions.

- Kelly- top line number appears to not be correct and needed to be looked into. There are goals for grants/sponsorship. The PSD comes in high in the first couple years and low in the last of the 5 year and we have pulled \$5000 a year in the beginning years for the end years. Event, placemaking, and PR are getting cut where we can to help make up the deficit of \$20000. They believe that the computer is calculating things incorrectly. According to assessor we should be maintaining \$50k and they are digging into why that is a change. Art walk is not bringing in the fundraising dollars. Peerless and Tribune Lofts are paying in. Want to stay conservative with the budget as we can always amend the budget. We have requested the info by the time we go to City Council in November for PSD renewal. Do we want to hold PSD at current level or do we want to ask for an increase of 1 or 2 cents.

Current is roughly \$95k if we increase by 1 cent we gain roughly \$10k and 2 cents gains roughly \$20k. There was an increase core prop by penny and Centertown has gone up four cents at last renewal. Council members have very little pushback in previous years when asked. DDA Communities are funded by TIF plan. Our TIF plan is used for more infrastructure. Start talking to district to see if we can get support to increase it. There has been no significant change as to how it has been spent.
