Grand Haven Chamber of Commerce – Art Festival Request

Jeremy reported that the Chamber would like to expand their event June 24 – 26, 2022 to include Friday.

Joy explained that the registration program used for their summer art festival has a long lead time, so they are needing to get the dates settled in a hurry. In 2022 they would like to start the event on Friday rather than waiting until Saturday morning.

With an early Saturday start, loading in at 1:00 a.m. was very problematic in 2021. Historically it is easier to set up during the day, with a street closure first thing Friday morning.

Historically, the parking prohibition has not been practical during the day after people already start parking downtown. We have waited until after the musical fountain show to shut the road down, and even then we end up towing several cars.

Close Washington at 3:00 a.m. Friday, June 24. Artists can start setting up at 5:00 a.m.
