B. Draft Song and Choreography Policy document

–Note: Committee needs to approve choreography before it can be run on the fountain.

MODIFICATION REQUEST to the Draft Musical Fountain Song and Choreography Policy:
“The list shall be maintained by the producer and be made available by the Secretary upon request.”

ANDY - Motion to forward the document to Derek as amended with request for clarification on the word majority and the change, "The list shall be maintained by the producer and be made available by the Secretary upon request."

QUESTION for Derek - Do we only need 3 yes votes to approve a song? What is the definition of "majority"? Do we need the majority of the committee or the majority of the quorum?

ANSWER from Derek: Simple majority, which is majority of the quorum.

ANDY- Motion to approve as clarified with "The list shall be maintained by the producer and be made available by the Secretary upon request."

SARA- Second

Passed unanimously

Full text of the Policy as approved:

The Musical Fountain Committee shall establish an official Song List by majority vote of the Committee. The list shall be maintained by the Producer and made available by the Secretary of the Committee to any one upon request. The list shall include only those songs and versions of songs that are legally available for the operation of the fountain.

The Committee shall, from time to time, add or delete songs from the official list by majority vote of the Committee. Only Committee members shall have the authority to introduce a song to the Committee for consideration, or recommend exclusion of a song at any official committee meeting. No song or choreography requests will be accepted from the public.

Once a song has been added to the official list, the committee shall then consider Appropriate choreography presented by any member of the Committee utilizing the fountain features and lighting. The Committee shall adopt proposed choreography by majority vote of the Committee.

All songs and choreography shall remain approved unless rescinded by majority vote of the Committee.

All volunteer choreographers shall be appointed and removed by majority vote of the Committee.

- Review of Music Licensing
 - Licensing can change year to year for artists. Nicki has tracked down all licensing numbers for our current catalog. Required to submit to the city what we played, when, and how often, to the City at the end of the year.
 - BRAD BOYINK COMMENT: Combining songs into Theme Shows can change the licensing requirement.
 - Nicki is working on a master spreadsheet with compliance information to make this a lot smoother in future years.
