- ii. Choreography Publicity & Training Update
 - 40 community individuals have reached out asking to learn how to choreograph music for the fountain. Combined with existing Choreographers and interested Committee members, our total is 48.
 - Training includes:
 - a. Two 2-hour class sessions on teaching individuals the basics of the software and techniques on the fountain. The training will be offered through Zoom video conferencing, and will be recorded for future reference.
 - b. Everyone will be provided with a song to work through. It will be the same song so we can compare everyone on an even playing field.
 - c. We will use it as a learning and community building activity.
 - d. We will be using Zoom to teach the courses because we have a lot of individuals outside of Grand Haven that want to help us out.
 - e. See the attached agenda items for the specific details for the courses and what is expected during the training.
