Chairman Van Hall opened the meeting to the property owners of the City of Grand Haven to hear protests of assessment. The following were protested.

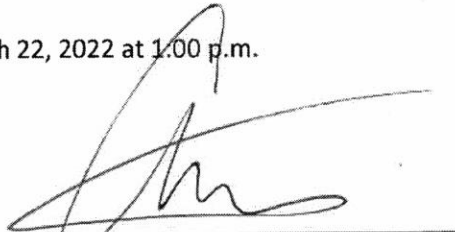
