5. Financial Report

Superintendent Vredevelde briefly discussed the current cash balances the Authority has and that we are still early in new fiscal year so no major expenses or maintenance has occurred that has impacted the budget

6. Superintendent's Report

June hexachlorobenzene detection, state has been notified and new pollutant minimization program has been implemented

2018 biosolids report – exceedance of zinc and nickel and notice was given from EGLE with a Communication Compliance (CC) letter.

Grand Haven Force main inspection showed no noticeable corrosion of the external steel.

Vacancy in our maintenance supervisor position – Crew leader has been established to help cover day to day maintenance

P&N submitted proposals for engineering, bidding assistance, and construction services for aeration baffle walls, and brick veneer for old headworks building.

East end park – Party in the park was a success, around 350-400 people attended. Additional funds will be raised through grants and further donations to accomplish fundraising goal for restoration of the basketball court on SA property

7. Lift Station 19 Flow Allocations – Village of Spring Lake & Spring Lake Twp.

Pat Staskiewicz provided a Memo regarding flow meter corrections between Village of Spring Lake and Spring Lake Township that will now be handled by the Sewer Authority and reported on monthly flow reports.

8. Staffing Restructure

Memo provided by Superintendent of WWTP explaining the proposed restructure of plant staffing

Due to vacancy in Maintenance Supervisor position we would like to remove that position and open a crew leader position instead.

Restructure does not need approval of the board – position is already in the union contract so restructure acceptable

E. MERS Contributions – Plant Management

Asking to reduce employee contribution from 17%

Cargo – Nonunion and union have the same benefit so it is isn't fair to reduce for two people and not the entire plant staff

Burns – table this discussion until after the City of GH knows future

F. Retention Bonus

Memo provided by Plant Superintendent explaining a proposed retention bonus

Many municipalities have given large raises and/or annual bonuses due to inflation. We feel that a 3% bonus is fair.

Cargo – this was meant to be only a bonus for the non-union employees because the union has already negotiated their contract and benefit. We don't have the authority to give collective bargaining members bonuses.

Motion by Cargo that the non-union employees receive a 3% wage increase in addition to the 3.3% COLA effective July 1st.
